

# LottaLingo Scouting Trip Participation Agreement

This Participation Agreement ("Agreement") is entered into between Trilingue Z LLC d/b/a LottaLingo, a Washington State limited liability company ("LottaLingo," "we," "us," or "our"), and the undersigned participant ("Participant," "you," or "your").

This Agreement governs your participation in the LottaLingo Relocation Scouting Trip (the "Program"), a multi-day relocation scouting experience. This Agreement may be signed electronically and shall have the same legal effect as a handwritten signature.

## 1. Purpose of the Program

The Program is designed to help participants explore neighborhoods, housing options, lifestyle factors, and community resources. The Program is not a guided tour, immigration service, real estate service, legal service, or a guarantee of relocation outcomes. We do not promise, guarantee, or represent that participation will result in residency approval, housing availability, employment, or successful relocation.

## 2. Eligibility

You must be 18 years of age or older to participate. You confirm that you are physically and mentally fit to travel and participate in group activities.

## 3. Personal Responsibility & Assumption of Risk

International travel involves inherent risks, including but not limited to illness, injury, delays, transportation incidents, weather, crime, and changes in local conditions. By signing this Agreement, you:

- Accept responsibility for your health, safety, conduct, travel documents, and personal belongings.
- Accept responsibility for obtaining and maintaining travel/medical insurance or accept the risk of declining such insurance.
- Agree that LottaLingo does not provide medical care, legal advice, immigration services, or insurance coverage.

## 4. What Is Included / Not Included

Included:

- Accommodations for the Program duration (hotel or airbnb)
- Daily breakfast and dinners on the first and last nights
- Group transportation between Program cities
- Neighborhood, rental, or property tours
- Custom activities designed around the interests of the group

Not Included:

- Flights to/from the Program
- Travel documents, visas, residency permits, or insurance
- Personal expenses
- Legal, tax, housing, or immigration services
  - These may be made available at a discounted rate after the trip

## 5. Payments, Deposits & Refunds

A €1,500 deposit is required to reserve your spot and must be paid within 14 days of acceptance. The final Program price will be determined once the final itinerary is confirmed.

### Refund Policy:

You may receive a full refund of your deposit (less transaction fees) if you cancel within 14 days of payment. After 14 days, your deposit becomes non-refundable but fully transferable to another LottaLingo scouting trip subject to availability. If LottaLingo cancels the Program, you will receive a full refund of all payments made.

## 6. Conduct & Removal

This is a small, community-based experience. You agree to act respectfully toward fellow participants, staff, and local partners. LottaLingo reserves the right to remove any participant from the Program, without refund, for reasons including but not limited to:

- Harassment or discriminatory behavior of trip participants, trip leaders, or trip partners
- Disruption or violation of the group's rules or safety instructions
- Illegal activity

## 7. Media Release

During the Program, LottaLingo may take photographs, video, or audio recordings of participants while conducting activities like cooking classes or walking tours. We may use these materials on our website, social media, and printed materials.

## 8. Limitation of Liability

To the fullest extent permitted by law, LottaLingo, its owners, contractors, partners, and trip leaders shall not be liable for any injury, loss, damage, delay, or expense arising out of participation in the Program.
